

PRESIDENT-ELECT

Madeleine Swortwood, Ph.D. is currently a Toxicology Expert at Robson Forensic. Previously, she was a tenured Associate Professor in the Department of Forensic Science at Sam Houston State University. Dr. Swortwood received a Bachelor's degree in Biochemistry from Duquesne University and a Ph.D. in Chemistry from Florida International University (FIU). She completed a postdoctoral fellowship with the National Institute on Drug Abuse under the mentorship of Dr. Marilyn Huestis. During graduate school, Dr. Swortwood served as an intern at the Food and Drug Administration's Forensic Chemistry Center and the Miami-Dade Medical Examiner's Toxicology Laboratory, where she was hired as a full-time forensic toxicologist.

Madeleine is currently Secretary on the Board of Directors for SOFT. She is a member of the SOFT/AAFS Oral Fluid Committee. Previously, she served on the SOFT Publications Committee and the SOFT/AAFS Drugs & Driving Committee. She is past Chair of the AAFS Toxicology Section and serves on the OSAC Toxicology Subcommittee. Her research to date includes novel psychoactive substances, oral fluid drug testing, drug metabolism, in utero drug exposure, and analytical method development. She has authored and co-authored more than forty manuscripts and one book chapter. She mentored dozens of MS and PhD students while at SHSU.

SECRETARY

Dayong Lee, Ph.D., F-ABFT, is the manager of the Toxicology section and the chief toxicologist at the Houston Forensic Science Center (HFSC). Prior to her tenure with HFSC since 2015, she served as an Intramural Research Program fellow at the National Institute of Drug Abuse conducting her graduate research on cannabis and subsequently as a postdoctoral associate of the clinical and forensic toxicology laboratories at the University of Florida. Dr. Lee is certified as a fellow by the American Board of Forensic Toxicology and as a toxicological chemist by the National Registry of Certified Chemists and licensed as a Toxicologist (Interpretive) by the Texas Forensic Science Commission. She serves as a director of the American Board of Forensic Toxicology, the Co-Editor-in-Chief for the Journal of Analytical Toxicology, and a Sentinel Site Director for the National Drug Early Warning System. She is an active member of the Society of Forensic Toxicologists, currently serving as a director of the Board; she previously served as the Chair of the Drugs and Driving Committee, members of the Membership Committee, History Committee, and Awards Committee, as a mentor for the Mentoring Committee, a moderator for the SOFTopics, and as the 2019 Scientific Program Co-Chair. Additionally, she is a fellow of the American Academy of Forensic Sciences, currently serving as the Chair of the Toxicology section, as well as members of the International Association of Forensic Toxicologists, the American Society of Crime Laboratory Directors, and the National Safety Council - Alcohol, Drugs and Impairment Division. She received several awards including AAFS Irving Sunshine Award, Young Scientist Award from the International Association of Forensic Sciences, NIH Outstanding Graduate Research, and SOFT Education Research Award. Dr. Lee authored 39 peer reviewed articles and 2 book chapters and presented at national and international professional conferences on diverse topics of forensic toxicology including oral fluid cannabinoids, case reports, drug trends and others. She received a Doctor of Philosophy degree in toxicology from the University of Maryland in Baltimore, a Master of Science degree in forensic science from the University of Illinois in Chicago, and a Bachelor of Science in microbiology and cell science from University of Florida. She is currently a candidate for the Master of Liberal Arts (ALM) in Extension Studies, field of Management, Harvard University.

DIRECTOR

Erin L. Karschner, Ph.D., F-ABFT, Dr. Erin L. Karschner received her Ph.D. in Toxicology from the University of Maryland-Baltimore. As part of her predoctoral fellowship, she performed clinical research studies exploring cannabinoid pharmacology at the National Institute on Drug Abuse (NIDA). After completing a postdoctoral fellowship at NIDA, Dr. Karschner was hired as a research scientist at Aegis Sciences Corporation where she developed and validated analytical methods for pain management medications, illicit drugs, and novel psychoactive substances. Dr. Karschner is currently a Forensic Toxicologist at the Armed Forces Medical Examiner System's Division of Forensic Toxicology. In addition to her duties as a laboratory certifying official and expert witness, she is an advisor on technical issues related to research initiatives and analytical challenges. She has published 29 peer-reviewed publications and currently serves on the Journal of Toxicology (JAT) and Journal of Forensic Sciences editorial boards.

A founding member of the SOFT Young Forensic Toxicologists Committee (2009–2014), Dr. Karschner expanded her service to the Awards Committee (2018–2021), Professional Mentoring Committee (2020–2022), Publications Committee (2024), and the Drugs and Driving Committee (2019–present). She has served as a SOFTopics moderator (2020–2024), Workshop Program Coordinator (2019), Meeting Co–host (Nashville 2021), and the Special Issue Editor for JAT (2024). Dr. Karschner is also active outside of SOFT, serving on the American Board of Forensic Toxicology's Board of Directors and the National Safety Council's Alcohol, Drugs and Impairment Division as the Cannabis Section Chair. She was the Toxicology Section Program Chair for the 2025 American Academy of Forensic Sciences (AAFS) Meeting.

Dr. Karschner has had the honor of receiving the SOFT Educational Research Award, the AAFS Toxicology Section June K. Jones Award, the AAFS Toxicology Section Irving Sunshine Award, the International Association of Forensic Toxicologists Best Bulletin Paper Award, and the SOFT Young Forensic Toxicologist Service Award.

DIRECTOR

Alex J. Krotulski, Ph.D., Dr. Alex J. Krotulski serves as the Director of Toxicology and Chemistry at the Center for Forensic Science Research and Education (CFSRE) where he has worked since 2015. In this role, Alex is the Program Manager for NPS Discovery, the CFSRE's open-access drug early warning system. Alex holds faculty appointment at Thomas Jefferson University and serves as the Program Director for their M.S. degree program in forensic toxicology. Alex is a Senior Associate Editor for the Journal of Analytical Toxicology. Alex is an active member of several professional organizations, including SOFT, TIAFT, and AAFS. Alex actively serves as the vice chair of the SOFT NPS Committee and as a member of the TIAFT NPS Committee. Alex was the 2021 JAT Special Issue Guest Editor, was the 2024 Workshop Chair, and has served on the Nashville planning committee, St. Louis planning committee, and publications committee. Alex has published more than 80 peer-reviewed publications and has given more than 140 presentations at conferences and meetings. In recognition of his accomplishments, Alex was the recipient of the 2021 SOFT Research in Forensic Toxicology Award, the 2022 AAFS Toxicology Section's Irving Sunshine Award for Outstanding Research by a Young Investigator, and the 2025 AAFS Past Presidents Council's Outstanding Early Career Achievement in Forensic Science Award.



Title: Fast & Forensic: Rapid Detection & Quantitation of 30 + e Emerging Novel Psychoactive Substances in Hair

About Seokjin: I have been attending John Jay for 6 years through bachelor's and master's degree. I have graduated bachelor's in 2019 and went to the Korean army for 2 years and came back in 2023. I met my wonderful mentor, Dr. Ana Pego, around 2024 and have been working on NPS with her since. Title: Analysis of Cannabinoids and Semi-synthetic Cannabinoids in Authentic Breastmilk by Liquid Chromatography-Tandem Mass Spectrometry

About Marco: I received my Doctor of Philosophy degree in Nanoscience and Advanced Technologies-Technologies and Nanotechnology in Forensic Sciences from the University of Verona, Italy in 2023. I currently serve as a Postdoctoral Associate at the Forensic Toxicology Laboratory, Department of Pathology, Immunology and Lab Medicine, University of Florida College of Medicine. My main activities focus on the development and validation of an LC-MS/MS assay for the determination of cannabinoids in various matrices as a part of a study assessing prevalence of medical/non-medical marijuana, and cannabidiol use during pregnancy and postpartum, as well as participation in the process of transferring routine methods from GC to LC systems.



What do you find most exciting about forensic toxicology research?

Certainly, the aspects that make this discipline so dynamic. I've always been fascinated by laboratory research in both clinical and legal investigations, and by the fact that every case or study is unique. For me, forensic toxicology brings all of that together and represents the ideal field where I can keep learning, stay challenged, and be involved in work with meaningful social impact.



Committee Members oversee the planning and coordination of the YFT Symposium, Professional Development Fair, Student Enrichment Program, and the Leo Dal Cortivo Awards at the annual SOFT meeting

During the first few quarters of the year, the Regional Toxicology Liaison (RTL) Program continued its mission to strengthen forensic toxicology across the United States. The RTLs worked collaboratively to support laboratories, law enforcement, judicial systems, and traffic safety offices. Their efforts focused on improving testing standards, enhancing data reporting, and fostering partnerships that advance impaired driving initiatives.

Training and education remain a top priority. The RTLs delivered testimony training to toxicologists in Kentucky, working with the DRE State Coordinator and TSRP to help toxicologists prepare for courtroom presentations. The RTLs also spoke at major conferences, including the International Association of Chemical Testing (IACT), the Arizona Drug Treatment Court Conference, the Midwest Association of Toxicology and Therapeutic Drug Monitoring (MATT), and the AllRise conference, sharing insights on drug trends and toxicology standards.

The RTLs also played a crucial role in educating judges and prosecutors. They are working with the National Traffic Law Center to update the Alcohol Toxicology Monograph and have taken part in webinars hosted by the American Bar Association. These efforts aim to enhance understanding of toxicology in legal settings and to ensure accurate interpretation of forensic evidence.

Support for legislative and traffic safety continued to grow. The RTLs offered expert advice on Michigan's oral fluid bill and collaborated with state highway safety offices and impaired driving task forces across the country. Kristin Burke (Western Region) met with Michigan lawmakers and gave informational testimony, both virtually and in person.

In early July, the RTLs attended the Association of Transportation Safety Information Professionals (ATSIP) Traffic Records Forum (TRF). Traffic safety often overlooks toxicology, and it is important to ensure the field is represented in the state and national data systems. The RTLs are working on a potential pilot project that involves a laboratory and the integration of their result data into a traffic safety data system.




